Sanction Order

**Subject:** Release of Grant -in-Aid (non-recurring) to the Public works Department, Government of NCT of Delhi for creation of barrier free environment in Hospital buildings for the benefit of Persons with disabilities under the Accessible India Campaign.

In pursuance of the letter of DEPwD, Ministry of Social Justice & Empowerment, Gol vide No. F. No. 4-72/2016-AIC (Pt.2) dt. 27/12/2016, I am directed to convey the administrative approval and expenditure sanction of the Secretary (SW) being the competent authority for release of funds to the tune of Rs. 1,64,20,302 (one crore sixty four lakh twenty thousand three hundred two only) in favour of Executive Engineer (E) BPD B-242(N), PWD, GTB Hospital Complex, Shahdara, Delhi-110095 as 1st installment of the grant-in-aid under Centrally Sponsored Plan Scheme called the Scheme for Implementation of Person with Disability Act 1995 (SIPDA) for incurring expenditure on creation of barrier free environment in Hospital buildings as per details given in Annexure-I under Accessible India Campaign (AIC).

The expenditure on the above referred amount of GIA will be debited to the Demand no. 08 Major Head 4235 02101820053 under Scheme for Implementation of Persons with Disabilities Act 1995 (SIPDA)(CSS)(SubHead) for the financial year 2017-18.

The sanction of expenditure is subject to the following conditions:-

1. The Grant-in-aid will be regulated in accordance with the provisions contained in the General Finance Rules (GFR), 2017. The Grant-in-aid is also subject to the Chapter 9 (I) of the General Finance Rules (GFR), 2017, as amended from time to time and read with the Government of India's decisions incorporated there-under, and any other guidelines which may be issued in this regard, and in particular to the following conditions:-
  - a. The accounts of the grantee institution shall be open for audit by C&AG or by any person authorized by him on his behalf in accordance with the provisions laid down in Section 14 of the C&AG (DPC Act, 1971) as amended from time to time.
  - b. The Accounts of the grantee institution shall be open for inspection by the DEPwD, MSJE, Gol and Audit, both by any other Comptroller & Auditor General of India under the provision of C&AG (DPC Act, 1971) and Internal Audit by the Principal Accounts office of the Ministry or Department whenever it is called upon to do so.
2. Grants-in-aid to the grantee institution are subject to the economy instructions issued from time to time by the Ministry of Finance or by any other competent Authority.
  - a. The grantee shall submit the final Utilization Certificate for the entire grant along with a project completion report within three months after completion of the work/project as stipulated in the proposal. Unutilized money, if any, is to be refunded to the Department. In case the work/project is not completed within the stipulated timeframe and further time is sought to complete the same, the grantee concerned has to intimate the Ministry and this Department and also explain the reason for the delay. If the project is not

- completed within the time frame/extended timeframe, the grantee organization has to refund the grant amount forthwith.
- The grantee shall furnish to this Department the progress report on the project indicating both physical and financial achievements in relation to the approved project.
  - The works has to be allotted as per terms and conditions laid down in General Financial Rules/ Codal procedure /CVC Guidelines in the matters of contract /financial transactions.
  - All other relevant terms and conditions as laid down in GFR would be applicable.
  - The grantee will prominently display details of grant-in-aid received, purpose thereof, events organized and list of beneficiaries, wherever applicable on their Website.
