ORDER

In continuation to the earlier order no. F.80/208/Admin. Matter/DSW/8963-8988 dated 03/07/2017, F.80/208/Admin. Matter/DSW/12545-572 dated 03/08/2017 and F-41(228)/DSW/FAS/e-District/'16'17/ 505-525 05-09-2017, regarding verification of Old Age Pension application forms on the e-district portal, also all DSWOs and verifiers (as per the attached list) may kindly note:

1. All verifiers shall verify the application forms for the Districts where their IDs have been created, from their current place of physical posting.
2. New verifiers have been added to complete the verification exercise.
3. Districts of few verifiers have been changed as per requirement. The verifiers shall continue the verification of the newly allotted district.
4. Each verifier is expected to verify minimum 50-60 application forms per day, as the verification exercise has to be completed by 3rd October 2017.
5. The verifier wise daily status report is being monitored by the highest authorities. The verification exercise shall continue on all days including Saturdays, Sundays and all Holidays, until further orders.
6. Computer cell must ensure that all verifiers have computers with internet connection for the said purpose.

8. All Dy. Directors shall ensure that the verifiers posted in their branch are completing the said verification process.


