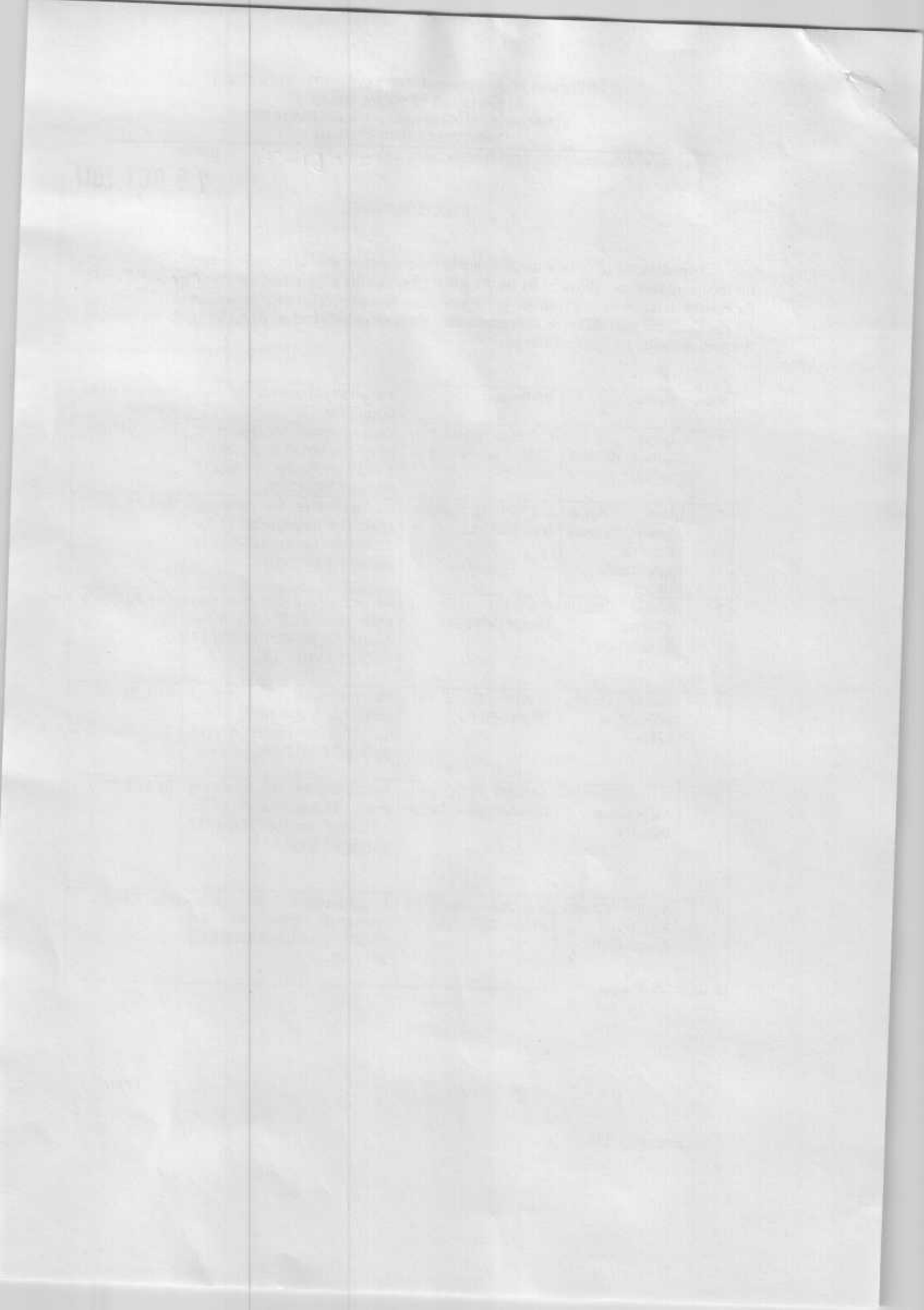
**SANCTION ORDER**
