**ORDERS**

Regarding grant of NOC to **10-15 years old Diesel vehicles**, the Hon'ble National Green Tribunal vide its order dated 20.07.2016 directed that '...State has to identify areas where the dispersion of the air is higher and vehicular density is least, if the States have not done it so far we grant last opportunity to the States and the Union Territories to identify such areas and put them on the respective websites. The RTO, Delhi will issue NOC for transfer of these vehicles only for such areas which are identified by the States. The diesel vehicles which are more than 15 years old and are BS I or BS II compliant shall be scraped and no NOC will be issued for transfer of the vehicle...'

The information received from the States till date is detailed below. Accordingly, All the Registering Authorities / MLOs may issue NOCs in r/o 10-15 year old Diesel vehicles only to the Districts permitted by the concerned States.
