ORDER

Subject: Issue related to via of route number F709A.

1. The route No. F709A (Najafgarh- Palam) was extended upto Mahipal Pur via Dwarka Sector 6-10, Bagdola, Dwarka Sector 21 under pass, Pushpanjali, Samalkha crossing, Rangpuri to Mahipal Pur by the STA Board during meeting held on 15-09-2014 subject to approval of Traffic Police. However, on the request of the operators, via from Palam Gaon to Palam Airport, Shankar Vihar and Mahipal Pur were allowed by Chairman, STA vide order dated 19-04-2016, subject to post facto approval of STA Board. Accordingly, revised permits were issued to operators by the STA Branch.

2. On receipt of objections from operators of route No. F-711A, the matter was placed before STA Board in its meeting held on 29-05-2017. The STA Board after considering the representations of the operators of route No. F709A and F711A resolved not to grant ex-post facto approval for change of via of route No. F709A from Shankar Vihar and these operators (F709A) will continue to operate on their original route via through Rang Puri, Samalkha and Dwarka underpass. It was further resolved that in future, no route modifications should be allowed without calling objections from affected parties. Therefore, the operators of F709A were directed to obtain the amended permit by submitting old revised permit.

3. The operators of route no. F 709A had requested that in place of via given by STA Board, their route via may be considered for change in the following manner:

"Najafgarh- Mahipalpur via Deenpur, Goyla Diary, Shyam Vihar, Sector-19, Dwarka Sec. -09, Sector-21, Under Pass, Rangpuri and Mahipalpur."



4. The matter was again placed before STA Board during the meeting held on 04-09-2017. The matter was deliberated in detail and STA vide its resolution no. 33/2017 resolved that the new via suggested by the operators of Route No. F709A may be placed in public domain for soliciting objections from the other operators and till then, the via approved by STA in the meeting of 29-05-2017 shall prevail.

5. In view the decision taken by STA, objection/suggestion is solicited from the affected operators on the following revised via requested by the operators of route no.F 709A:

"Najafgarh- Mahipalpur via Deenpur, Goyla Diary, Shyam Vihar, Sector-19, Dwarka Sector-09, Sector-21, Under Pass, Rangpuri and Mahipalpur."

6. The objection/suggestion, if any, may be forwarded to Secretary, STA, Transport Department, 5/9, Under Hill Road within 7 days from the date of publication.
