ORDER


In order to simplify the procedure of empowerment of self-registering dealers, a committee was constituted vide order No. DC/OPS/TPT/2015/459/5295-5300 dated 22.12.2016 headed by Dy. Commissioner (Operations-I) having Dy. Controller of Accounts, MLO (Operations) & MLO (Sheikh Sarai) as members.

2. Considering the fact of real time deposit of tax amount and prevailing procedure in other states, the committee recommended as under:-

- a) *The provision of advance deposit of road tax and registration fee of 15 days sale may be substituted by security deposit in the form of bank guarantee of Rs. Five Lakhs in case of two wheeler dealers and Rs. Ten Lakhs in case of four wheeler dealers in favour of Commissioner (Transport) to be deposited at the Accounts Branch of Transport Department.*
- b) *The dealer should prominently display the applicable fee / charges being charged by them from the purchasers. The display board should be placed at conspicuous places i.e. Reception Counter, Vehicle Display area, Sale Counters and the places where vehicles are delivered.*

3. The competent authority has considered the recommendations of the committee and in view of the fact that road tax is being deposited through on-line software of NIC on real time basis, it has been found appropriate to rationalize the security deposit for the empowerment of Self Registering Dealers.

4. Accordingly, it has been decided to accept the recommendations of committee referred above and henceforth, the security deposit in the form of Bank Guarantee for empowerment of Self-Registering Dealers will be as under:-

S. No.	Non-Transport (Private) dealers of	Security deposit in the form of Bank guarantee Amount (Rs.)
1	Four wheelers	Ten lakhs only
2	Two wheelers	Five lakhs only

5. The dealer should prominently display the applicable fees / charges being charged by them from the vehicle purchasers. Display boards should be placed at conspicuous places i.e. Reception Counter, Vehicle Display area, Sale Counters and the places where vehicles are delivered.

6. Further, as the registration of motor vehicles is being done online and the taxes are also being deposited on real-time basis, the security deposit will be refunded through on-line process by Accounts Branch on deposit of Bank Guarantee mentioned above in respect of all existing Self-Registering Dealers.

7. The other conditions prescribed in the earlier guidelines will remain un-changed.

8. This proposal has been examined by the Finance Department, Govt. of NCT of Delhi and approved by the competent authority.


