Governor, NCT of Delhi has accorded his approval to the Cabinet decision No. 2200 dated 01.09.2015 to provide **Dragon Software** to the Standing Counsels(Civil/Criminal)/Additional Standing Counsels (Civil/Criminal)/Panel Advocates and APPs of Govt. of NCT of Delhi, High Court. The following terms and conditions, as subsequently decided in the meeting chaired by the Chief Secretary, Government of NCT of Delhi and also attended by of the Principal Secretary (Finance), Secretary (Law, Justice & LA), Secretary (I.T), Spl. Secretary (Finance) and Additional Secretary (Law, Justice & LA) will be applicable, namely:

1. Each Standing Counsels (Civil/Criminal), Additional Standing Counsels (Civil/Criminal), Panel Advocates and APPs will purchase the Dragon Software from M/s ICONS Infocom P. In compliance of order dated 06.08.2015 in Writ Petition (Criminal) No. 1549/2009 titled as "Court on its own motion vs. State" passed by Hon'ble High court of Delhi, the Hon'ble Lt. Governor, NCT of Delhi has accorded his approval to the Cabinet decision No. 2200 dated 01.09.2015 to provide **Computer/Laptop** to the Standing Counsels (Civil/Criminal), Additional Standing Counsels (Civil/Criminal), Panel Advocates and APPs of Govt. of NCT of Delhi, in Delhi High Court. The following terms and conditions, as subsequently decided in the meeting chaired by the Chief Secretary, Government of NCT of Delhi and also attended by of the Principal Secretary (Finance), Secretary (Law, Justice & LA), Secretary (I.T), Spl. Secretary (Finance) and Additional Secretary (Law, Justice & LA) will be applicable, namely:

1. The cost of Computer/Laptop has been restricted to maximum ceiling of Rs. 50000/- (Rupees Fifty Thousand only) once in every five years.
2. The Computer/Laptop will be purchased by the Panel Advocates/APPs concerned and the department will reimburse the full amount subject to prescribed ceiling.
3. The Panel Advocates/APPs after having made the requisite purchase will furnish the bill alongwith MAC ID/No. to this department and on receipt of such bill, the department will reimburse the amount to the Advocate concerned directly.
4. In case the cost of Laptop/computer exceeds this prescribed ceiling, the extra cost will be borne by the concerned Panel Advocates/APPs.
5. In case the engagement of the Panel Advocates/APPs comes to an end before the period of five years from the date of purchase of Laptop/Computer, then he/she must return the equipment or its equivalent cost after deducting the depreciation applicable. In case the Counsel continues for the period of 5 years from the date of purchase of Laptop/Computer, then he/she may retain the equipment.

6. The rate of depreciation for Laptop/Computer will be calculated as under:

1 st Year	25%
2 nd Year	25%
3 rd Year	20%
4 th Year	20%
5 th Year	10%

7. The Panel Advocates/APPs will have to give an undertaking in writing that these equipments shall be used primarily for safeguarding the interest of the Government of NCT of Delhi.
