Subject: Formulation of State Rules by virtue of the provisions in the RPwD Act, 2016

The Rights of Persons with Disabilities Act, 2016 came into force w.e.f. 19/04/2017. Section 101 of the Act gives power to the State Government to make rules under the Act. The Central Government prepared Model Rules to enable the State Government to formulate its own State Rules within the domain of the State Government by virtue of the provisions in the RPwD Act, 2016.

The Department of Social Welfare, Govt. of NCT of Delhi is the Nodal Department for formulation of the State Rules as per the provisions in the RPwD Act, 2016. With a view to implement the provisions of the new Act, Govt. of NCT of Delhi is in the process of framing rules for the State of Delhi.

The draft State Rules as formulated by Department of Social Welfare, Govt. of NCT of Delhi on the basis of model rules provided by the Central Govt. is uploaded and available on the website of the Department i.e. www.socialwelfare.delhigovt.nic.in for inviting Suggestions and Objections on the draft Rules.


