Nature of work:-The empanelled Counsellor and Psychologist is expected to assist the Children's/ Special Court and/or Juvenile Justice Board as under-

- To assist the victim of sexual offences under Protection of Children from Sexual Offences Act, 2005 and read with Model Guidelines U/s 39 of the said Act prepared by Ministry of WCD, GOI which provides directions for the professional during pre-trail and trail stage under the Act.
- To submit the report to the Children's/ Special Court so as to assist in the proceeding in the case.
- To understand the child's physical and emotional state and to resolve trauma and foster healing and growth.
- 4. To hear the child's version of the circumstances leading to the concern
- 5. To respond appropriately to the child when in crisis & to guide the family accordingly
- 6. To provide counseling, support, and group-based programs to children referred to them
- To improve and enhance the child's overall personal and social development, and his/her health and wellbeing
- 8. To facilitate the reintegration of the child into his/her/family/community
- to conduct preliminary assessment w.r.t. children in conflict with law under heinous offences U/s 15 of Juvenile Justice (Care & Protection of Children) Act, 2000/2015.
- 10. to assess the mental and physical capacity to commit such offence, ability to understand the consequences of the offence and the circumstances in which he allegedly committed the offence. The preliminary report of the psychologist will help to assist the Board in taking decision whether there is a need for trial of such child as an adult.

Duration of work: - Maximum 2 visits of 2 hrs. duration per case or as per the requirement of the case or as per the direct ions in the matter by Hon'ble Children's/
Special Courts or Juvenile Justice Boards. No extra remuneration will be pay beyond the fixed amount.

Remuneration:

The empanelled Psychologist shall be paid Rs. 2500/- per visit and the Counsellor shall be paid Rs. 1000/- per visit. The payment will made after duly verification of Bills by the office /Court/Board where the services of the professional were utilized/rendered. The bills will be deposited in the O/o Dy. Director, SCPS, DWCD (H.Q).
