Non functional Selection Grade to above mentioned official is on the basis of eligibility list provided by Cadre Controlling Authority i.e. Services-II Department in r/o Sr. Assistants. It is subject to the condition that, in future, due to addition or deletion of names in eligibility list, if there is a change in the date of eligibility in r/o above concerned Sr. Assistant, they will have no claim over the date of eligibility. HOO is requested to obtain an undertaking from the concerned official to this effect.

Further, NFSG is subject to the undertaking that in event of over payment, which may be detected at later stage, the same will be recovered from their pay.

The concerned HOO is requested to issue formal orders for grant of NFSG in r/o of official working in his institutions/homes/project complying DOPT OM no. 20/49/2009-CS-II(B) dated 22.6.11 of Govt. of India, Ministry of Personnel, Public Grievances & Pension(Deptt. of Personnel & Training), and order 58 dated 03.02.2015 of services Deptt.

However, before the issuance of formal orders the Head of Offices may again confirm that the official is clear from vigilance angle.

The officials concerned may be allowed to exercise his option, if any, under FR. 22 within one month of the issuance of the order granting the Non Functional Selection Grade.
