





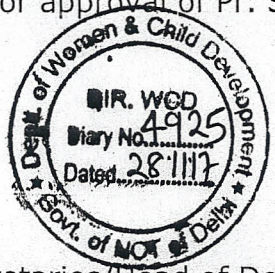
Sub:- Non-transfer of TDS amounts to Govt. Accounts or non-filing/incorrect filing of TDS statements by deductors.

Kind attention is invited to D.O. letter No.CIT (TDS)-1/2017-18/1648 dated 05/10/2017 received from Commissioner of Income-Tax (TDS-1) alongwith list of total outstanding demand of TDS as on 31/07/2017 from Financial Year 2007 against 22 AIN holders (Principal Accounts Offices) and their respective TANs.

It has been highlighted that several grievances have been received from the individuals including Central Government Employees regarding non-reflection of TDS amounts in their 26AS because of either non-transfer of TDS amounts to Govt. A/c or non-filing / incorrect filing of TDS statements by deductors.

In this regard, all the Pr. Secretaries / Secretaries / Head of Department of GNCTD are requested to impress upon DDOs for taking corrective measures to sort out the discrepancies as highlighted in the letter received from Commissioner of Income-Tax (TDS)-1 mentioned above. The copy of said letter alongwith the list of outstanding demand of TDS is available on the official website of Finance Department i.e. http://delhi.gov.in/wps/wcm/connect/lib_finance/Finance/Home/Centralized+Circular.
