**MEMORANDUM**

Whereas, vide this office Circular No. F.13(6)/Vig./WCD/2016/24493-527 dated 28.10.2016, directions were conveyed for observance of 'Vigilance Awareness Week - 2016' w.e.f. 31<sup>st</sup> October, 2016 (Monday) to 05<sup>th</sup> November, 2016 (Saturday). A compliance report in this regard was sought latest by 10<sup>th</sup> November, 2016.

Whereas, despite reminders dated 16.11.2016 and 24.11.2016, the requisite reports has not been received from some districts, due to which consolidated report on behalf of the department could not be submitted to the Directorate of Vigilance, GNCTD, within the prescribed time.

Whereas, the above detailed delay, clearly reveal that some of the authorities of the department are not dealing diligently with the matters referred by the Vigilance Branch (HQ.) and that too for a considerable period of time, without any justifiable reason.

**Now, through the present memorandum, the below mentioned officers are directed to show cause as to why the abovementioned Action Taken Report has not been submitted within the prescribed time limit and as to why action for negligence, insubordination, dereliction of duties and willful delay, be not initiated against them under the relevant provisions of the CCS (CCA) Rules, 1965.**

The reply to this memorandum must be submitted within 07 days, failing which it shall be presumed that the authorities concerned have not justifiable reason for defence and action as deemed fit shall be initiated.
