- 2. The contract may remain in force for the FY period of 2016-17.

- **4.** <u>Technical Bid</u> Sealed envelope of `<u>Technical Bid'</u> should consist of Documents as given in Annexure III.
- **5.1.** EMD:- The contractor shall deposit Bid Security (EMD) for an amount of Rs. 49,000/- in the form of an Account Treasury Challan or demand draft or pay order or Banker's cheque or deposit at Call Receipt or fixed deposit receipt drawn in favour of Director, Department of Women and Child Development, issued by a scheduled bank. In the event of failure to delivery or dispatch the items within the stipulated date/period in accordance with the specifications mentioned in the supply order and in the event of breach of any of the terms and conditions mentioned in the supply order, Department of Women and Child Development should have the right:
- (i) To recover from the successful tenderer as agreed liquidated damages, a sum not less than 0.5%(half percent) of the price of any item which the successful tenderer has not been able to supply as aforesaid for each week or part of a week during which the delivery of such stores may be in arrears limited to 10%. Where felt necessary the limit of 10% can be increased to 15% at the discretion of Director, WCD.
- (ii) To purchase elsewhere, after due notice to the successful tenderer on the account and at the risk of the defaulting supplier the stores not supplied or others of a similar description without cancelling the supply order in respect of the consignment not yet due for supply or —
- (iii) To cancel the supply order or a portion thereof, and if so desired to purchase the stores at the risk and cost of the defaulting supplier and also –
- (iv) To extend the period of delivery with or without penalty as may be considered fit and proper, the penalty, if imposed shall not be more than the agreed Liquidated Damages referred to in clause (a) above.
- (v) To forfeit the security deposit full or in part.
- (vi) Whenever under this contract a sum of money is recoverable from any payable by the supplier, Department of Women and Child Development shall be entitled to recover such sum by appropriating, in part or in whole by deducting any sum or any other contract should this sum be not sufficient to cover the full amount recoverable, the successful tenderer shall pay Department of Women and Child Development on demand the remaining balance. The supplier shall not be entitled to any gain on any such purchase.
