**Sub : Regarding General Election to SDMC 2017 duty.**





(2) No suit or other legal proceedings shall lie against any such person for damages in respect of any such act or omission as aforesaid.  
(3) The persons to whom this section applies are Returning Officers, Assistant Returning Officers, Presiding Officers, Polling officers and any other person appointed to perform any duty in connection with the election, and the expression "official duty" shall for the purpose of this section be construed accordingly.
