**ORDER**

For extension of contractual engagement of contractual staff beyond 31.03.2017, Department had forwarded files (CD No. 000312376; 000290199; 070172316 and 070163004) seeking concurrence of Finance Department. The said files have been received back from FD with observations that as per O.M. No.F.1(8)/2015-AC/jsexp/862-865 dtd 26.04.2017 of Finance Department, recommendations of Integrated Financial Advisors (IFA) be added in the files, being forwarded to FD. Further approval of competent authority for extension of outsource deployment of outsource staff too is pending for approval of the competent authority.

Since in compliance of Delhi Cabinet decision, wages of all contractual/outsource staff are required to be disbursed by 15<sup>th</sup> of the month and in order to mitigate financial hardship to the contractual/outsource staff, approval of the Secretary is hereby conveyed for release of wages to contractual/outsource staff for the month of April, 2017 on remunerations fixed/paid during validity of previous engagement period, in anticipation of approval of the competent authority to the extension of engagement proposals.
