The inspection under Schedule IV of Food Safety Standards Act, 2006m Rules & Regulations 2011 shall be carried out, FSO if required, issue the improvement notice under section 32 of Food Safety Standards Act, 2006 shall be served to FBO. The Designated Officer of concern district shall take action on food related grievances/ PGMS, LG's Listening Post and written complaints of General Public etc. Food Safety Officers and field Assistants shall report to Designated Officers as indicated above, during the fortnight period FSO have to lift samples of vegetable and fruits and also lift samples of Gutka and Pan Masala with tobacco and / or nicotine. In compliance of directed dated 23.09.2016 of Hon'ble Supreme Court regarding total compliance of the ban imposed on manufacturing and sale of Gutka and Pan Masala with Tobacco and / or nicotine. The copy of direction dated 23.09.2016 passed by the Hon'ble Supreme Court has already been provided in the previous order. All the eateries outside and inside hospitals and school premised must be inspected and samples must be lifted for analysis.
