Order

In continuation to order of even number dated 16.02.2018 and 08.03.2018 the following Food Safety Officers, Field Assistants and Process Server are hereby attached with following Designated Officers for the next fortnight period w.e.f. 23.03.2018 to 06.04.2018 for enforcement of Food Safety Standards Act, 2006 and Rules & Regulations, 2011 for all aspects, in the jurisdictional area of concern Designated Officers. The following vehicles are also attached with Designated Officers & FSOs for field duties. In case of any urgency in the field duty the FSO shall be further directed to report to the Designated Officers of the concerned districts.

All Designated Officers shall look after the enforcement work related to their districts. The inspection under Schedule IV of Food Safety Standards Act 2006, Rules & Regulations 2011 shall be carried out by FSO and if required, the improvement notice under section 32 of Food Safety Standards Act, 2006 shall be served to FBO. The Designated Officers and FSOs have to take appropriate action against the Food Business Operator who is conducting his business without having FSSAI License/Registration. The Designated Officer of concern districts shall take action on food related grievances/ complaints received through various government agencies i.e., FSSAI portal, Department's website, PGC, PGMS, LG's Listening Post and written complaints of General Public etc. Food Safety Officers and Field Assistants shall report to Designated Officers as indicated above, during the above mentioned fortnight period for inspection and lifting of samples of Food items. FSOs have to lift samples of vegetable & fruits, Pan Masala with Tobacco and /or nicotine. In compliance of direction dated 23.09.2016 of Hon'ble Supreme Court regarding total compliance of the ban imposed on manufacturing and sale of Gutka and Pan Masala with Tobacco and/or Nicotine. The copy of direction dated 23.09.2016 passed by the Hon'ble Supreme Court was already circulated to all Designated Officers enclosed with order dated 21.12.2017. All the eateries outside and inside Hospitals and School Premises shall be inspected and samples must be lifted for analysis. PGMS complaint shall be attended before disposal date in case it could not be possible the Designated Officers has to give in writing for further interim disposal date.

Note:- As per direction, an special drive is being conducted for inspection of hygiene waste disposal and quality of chicken/meat at Murga Mandi, Ghazipur and across NCT of Delhi, therefore, the above mentioned all Food Safety Officers along with their Field Assistants /Process Servers have to report to Designated Officer Sh. P.M. Kothekar, Distt- East for their field duty on 26.03.2018, 27.03.2018 and 28.03.2018 for inspection under Schedule IV, FSS Act, 2006 and Rules & Regulations, 2011 and

lifting of samples of Chicken/meat from Murga Mandi, Ghazipur, Delhi and after that they will remain attached with their District concern Designated Officers for inspection and lifting of samples of chicken/meat from Chicken and meat shops in their concern districts on 02.04.2018 to 05.04.2018.
