**FIRE SAFETY CERTIFICATE**

Davender (Manager) and found that the said guest house building have **added 07 (seven) more rooms. Now the floor wise occupancy at Ground floor (03 guest rooms + reception), 1<sup>st</sup> floor to 4<sup>th</sup> floor (04 guest rooms at each floor), total 19 guest rooms** and have deemed complied with the fire prevention and fire safety requirements in accordance with rule 33 of the Delhi Fire Service Rules, 2010 and that the premises is fit for occupancy class **Residential Group A-1 as above 19 guest rooms only** with effect from ~~31/7/~~ 2018 for a period of **three years** in accordance with rule 36 unless renewed under rule 37 or sooner cancelled under Rule 40 and subject to compliance of the conditions under rule 38 of the Delhi Fire Service Rules, 2010.

Earlier owner was informed vide this department letter no. **F6/DFS/MS/GH/2009/1395** dated **19.05.2009** point no. 6 which clearly states, addition of room will be considered after getting the clarification Delhi Police Lic. Now Delhi Police recommended 7 guest rooms vide this latter no. 2889-97/Addl. C.P/Lic.(H) dated 04.10.2017.

The guest house building have **added 07 (seven) more rooms. Now the floor wise occupancy at Ground floor (03 guest rooms + reception), 1<sup>st</sup> floor to 4<sup>th</sup> floor (04 guest rooms at each floor), total 19 guest rooms.**

The fire protection systems provided in the building were randomly tested, checked and found functional at the time of inspection.

In view of the deemed compliance of the minimum standards of fire prevention and fire safety measures as required under the rules the FSC issued vide letter no. F6/DFS/MS/GH/2015/NDZ/1822 dated 09/10/2015 renewal under rule 35 of the Delhi Fire Service rules 2010, is recommended.
