In continuation to this office letter No.F-69 (II)/ DJB/ AC(G)-I/ M/ Roll/ Infmn./ 2017/ 76888 to 76922 dt. 11.12.2017, the Competent Authority i.e. Member (Admn.) vide his orders dated 12.01.2018 has been pleased to accord further extension up to the period 31.12.2018 (i.e. from 1.1.2018 to 31.12.2018) to the 22 muster roll workers as mentioned in the enclosed list as per Annexure "A" (from Serial no. 1 to 19) and Annexure "B" (from Sl.no. 20 to 22) subject to the following terms & conditions.

TERMS & CONDITIONS

1. The Muster Roll workers shown in the list will henceforth be covered under this sanction and their serial number should be quoted while dealing in official capacity in future.
2. The Muster Roll workers covered in the list will not be re-engaged or taken on duty, if they remain absent for 30 or more days continuously, without the specific sanction from the Competent Authority i.e. Member (Administration), Delhi Jal Board.
3. Mere appearance of one's name in the list does not make one entitled for muster roll wages. The controlling authority has to further ensure that the worker is presently working on Muster Roll and if a worker has been regularized or is running absent or no more on muster roll due to any reasons, whatsoever, his wages will not be released by the controlling officer and this fact will be reported to this office.
4. This sanction is not applicable in case of those Muster Roll workers who have engaged to perform work for a limited period for seasonal nature of work in different years.
5. The workers who are having technical designation, but are not having the required qualifications in this list and they have filed court cases against the department and those whom the criminal cases are pending in court "CC" have been marked against them. However, the extension is being given in terms of Section 33 of Industrial Disputes Act, 1947 and is subject to the outcome of the court case.
