Giri Raj Singh (Emp. 20002479), Assistant Engineer (Civil) C/o EE (Project)Water-I, after opening the sealed cover, is hereby promoted to the post of Executive Engineers (Civil) on ad-hoc basis with immediate effect initially for a period of one year in the first instance or till regular promotion is made by the UPSC or till further order whichever is earlier in Level -11 of Rs. 15,600-39,100 (pre-revised GP of Rs. 6,600/-) subject to terms and conditions as mentioned hereunder:-

Terms & Conditions.

1. The above ad-hoc promotion will be initially for a period of one year in the first instance or till regular promotion is made by the UPSC whichever is earlier.
2. The ad-hoc promotion will not confer any right on the officer to claim for regular promotion to the post or any other service benefit.
3. The Competent Authority can terminate the interim arrangement at any time without assigning any reason and giving any prior notice.
4. Other conditions of service will be governed by the relevant rules and orders that may be in force from time to time.
5. The above promotion will be also subject to final outcome of Writ Petition filed by Shri A.K.Awasthi and others before Hon'ble High Court, Delhi or any other.

Further, the posting orders will be issued separately.
