Consequent upon the recommendation dated 24.07.2018 by Departmental Screening Committee and further approval by CEO, DJB dated 25.07.2018, **following Junior Engineers (E&M) are hereby entrusted the look after charge to the post of Assistant Engineer (E&M) with immediate effect in addition to their duties as JE(E&M)**, as a stop gap arrangement on functional requirement, till such time these posts are filled in on regular basis or till retirement on attaining the age of superannuation or till further orders, whichever is earlier.

Further, the above arrangement is subject to following term & conditions :

1. They will also look after the work of Junior Engineer(E&M) in addition to their own duties as AE(E&M).
2. The entrustment of look after charge will be in their own pay scale of the post they are holding in substantive capacity i.e. JE(E&M).
3. It will not confer any right on the officers to claim for ad-hoc/regular promotion to the post or any other service benefits.

4. That the period of service rendered on look after charge will not count as officiating in the higher grade for any purpose including seniority in that grade and for eligibility for promotion to the next higher grade.
5. The competent authority can terminate the interim/stop gap arrangement at any time without assigning any reason and giving any prior notice.
6. Other conditions of service will be governed by the relevant rules and orders that may be in force from time to time.
7. The entrustment of look after charge is also subject to final outcome of various court cases pending before Hon'ble Courts, including L. N. Kulshrestha Vs DJB (OA No.698/2017.

Individuals will furnish their joining report to their controlling officers under intimation to this office as token of their acceptance to the above referred conditions. The above officials will continue to work at their present place of posting till their posting orders are issued.
