Sub.:--Payment of Non- Productivity Linked Bonus (Ad-hoc Bonus) to Contractual Employee (Directly by DJB) for the financial year 2017-2018.

The Chief Executive Officer vide his orders dated : 03.11.2018 has been pleased to accord approval for the payment of Non-Productivity Linked Bonus (Ad hoc Bonus) for the financial year 2017-2018, to all worker engaged on contractual - basis, directly by Delhi Jal Board, subject to fulfillment of the following terms & conditions.

1. The contractual basis who have worked in offices following six days week for at least 240 days for each year for 3 years or more (206 days in each year for 3 years or more in case of offices observing 5 day week), will be eligible for this Non- PLB (Ad-hoc Bonus) payment. The amount of Non-PLB (Ad-doc Bonus) payable will be ₹ 1200 X 30/30.4 i.e. ₹ 1184.21 (round off to ₹ 1184/-) in cases where the actual employments fall below ₹ 1200/- P.M., the amount will be calculated on actual monthly emoluments.
2. All payments under these orders will be rounded off to the nearest rupee.
3. The payment under these orders will be chargeable to the Sub-head "Salaries" in the relevant demand for grant of the organization concerned.
4. The expenditure incurred on account of Non-PLB (Ad-doc Bonus) is to meet from within the sanctioned budget provision of concerned Divisions/Offices for the current year.

This has been issued with the concurrence of Finance & Accounts Deptt. of Delhi Jal Board.

All the concerned DDOs are, therefore, requested to kindly ensure the payment of Ad-hoc Bonus for the financial year 2017-2018, accordingly to the contractual worker engaged on contractual-basis, directly by DJB, working under them, immediately.
