**ORDER**

**Cancellation of appointment/posting order to the post of PGT**  
**(Economics) Post code (130/12)**

Whereas, Mukesh Kumar (DOB-20/04/1986) (R.No. 28002114) had been nominated by DSSSB for the post of PGT (Economics) against post code 130/12 vide letter No. F.1(158)/DSSSB-P&P/2012/770-72 dated 09/11/2016 result notice No. 443 dated 17/10/2016 and accordingly an offer of appointment was issued vide this office Memorandum of even No. dated 06/09/2017 for initial verification of documents.

2. Mukesh Kumar (DOB-20/04/1986) (R.No. 28002114) had been appointed vide order of even no. dated 07/12/2017 and been given Emp. I.D 20172257 and posted in Rohini, Sector 11-G(Co-Ed)SSS – 1413023 with the direction to join latest by 22/12/2017.

3. Therefore, sufficient time and opportunity has been granted to Mukesh Kumar (DOB-20/04/1986) (R.No. 28002114) to join his place of posting. But Mukesh Kumar has chosen not to join the post of PGT (Economics), it can be seen that Mukesh Kumar is not interested to accept the appointment/posting order.

4. Further, DOPT Office Memorandum No. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned "An offer of appointment should be clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**"

5. Therefore, in view of para.3 and DoPT OM dated 09.08.1995 the appointment/posting order dated 07/12/2017 in respect of Mukesh Kumar (DOB-20/04/1986) (R.No. 28002114) is hereby cancelled and the dossier is returned to DSSSB.
