**Cancellation of appointment/posting order to the post of PGT  
(Geography) Post code (134/12)**

Whereas, Vikas Malik (DoB- 16/04/1988) (Roll No.-29000200) had been nominated by DSSSB for the post of PGT (Geography) against post code 134/12 vide letter No. F.1(158)/DSSSB-P&P/2012/208-10 dated 20/03/2017 result notice No. 472 dated 23/02/2017 and accordingly an offer of appointment was issued vide this office Memorandum of even No. dated 05/05/2017 for initial verification of documents.

2. Vikas Malik (DoB- 16/04/1988) (Roll No.-29000200) had been appointed vide order of even no. dated 27/07/2017 and been given Emp. I.D 20171662 and posted in Bawana J.J. Colony No.-2 GBSSS-1310415 with the direction to join latest by 11/08/2017. The candidate as per representation having Dy No. 3609/E-II had sought extension on domestic grounds and the same had been granted extension till 30/09/2017 and the candidate as per representation having Dy. No. 4738/E-II dated 25/09/2017 again sought extension due to domestic reasons and the same had been granted till 06/12/2017. However, the candidate once again has sought extension vide letter having Dy No. 2858/E-II dated 02/07/2018 and in view of the fact that the period of six months has lapsed, hence, no further request for further extension can be entertained.

3. Therefore, sufficient time and opportunity has been granted to Vikas Malik (DoB- 16/04/1988) (Roll No.-29000200) to join his place of posting. But Vikas Malik has chosen not to join the post of PGT (Geography), it can be seen that Vikas Malik is not interested to accept the appointment/posting order.

Further, DOPT Office Memorandum No. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned "An offer of appointment should be clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. **An offer of appointment would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**"

5. Therefore, in view of para.2 to 4 the appointment/posting order dated 27/07/2017 in respect of Vikas Malik (DoB- 16/04/1988) (Roll No.-29000200) is hereby cancelled and the dossier is returned to DSSSB.

Whereas, Ritu (DoB- 15/10/1983) (Roll No.-29000295) had been nominated by DSSSB for the post of PGT (Geography) against post code 135/12 vide letter No. F.1(158)/DSSSB-P&P/2012/208-10 dated 20/03/2017 result notice No. 473 dated 23/02/2017 and accordingly an offer of appointment was issued vide this office Memorandum of even No. dated 05/05/2017 for initial verification of documents.

2. Ritu (DoB- 15/10/1983) (Roll No.-29000295) had been appointed vide order of even no. dated 14/09/2017 and been given Emp. I.D 20171961 and posted in Hiran Kudna-SV-1617006 with the direction to join latest by 30/09/2017. The candidate had been granted extension till 06/12/2017 and the candidate sought further extension having dy no. 5478/E-II the same had been granted till 28/02/2018.
