OFFICE ORDER

Sh. Vishnu Kumar Bairwa was nominated by DSSSB vide letter No F.1(155)/DSSSB/P&P/12/470-72 dated 29.06.2016 for the post of TGT(Sanskrit), post code 116/12 Roll No.52000703 under SC category. Accordingly, an offer of appointment was issued to the candidate vide memo No DE.3(77)/E-III/DR/TGT(Sanskrit)/Male/2016/3122 dated 19.10.2016 with the direction to appear in person on 10.11.2016 in the office for verification of his educational qualification certificates and other documents. During verification of documents it was revealed that the candidate has possessed BA(Hons.) in Geography with Sanskrit as a subsidiary subject in all three years of his graduation.

Whereas, as per existing Recruitment Rules the educational qualification for the post of TGT(MIL) should be as below:

- (i) BA(Hons) in one of the Modern Indian Languages(MIL) concerned or B.A with MIL concerned as one of the Elective subjects from a recognized University having 45 percent marks in aggregate with one additional language or one school subject at degree level.

OR

Equivalent Oriental Degree in MIL concerned from a recognized University having 45 percent marks in aggregate.

- (ii) Degree/Diploma in teaching

OR

Senior Anglo Vernacular Certificate

- (iii) Knowledge of Hindi is essential.

Whereas, the candidate has possessed the degree of **BA(Hons.) in Geography** and not in the MIL concerned i.e. Sanskrit. Thus, the candidate has not possessed BA(Hons.) with MIL concerned i.e. Sanskrit. Hence, the candidate did not fulfil the required educational qualification as per existing Recruitment Rules for the post of TGT(MIL). Therefore, the candidature of Sh. Vishnu Kumar Bairwa(Roll No.52000703) for the post of TGT(Sanskrit) under post code 116/12 is hereby cancelled and offer of appointment dated 19/10/2016 is withdrawn.

This issues with the prior approval of Competent Authority.
