**Cancellation of appointment/posting order to the post of PGT
(Hindi) Post code (137/12)**

Whereas, Anupma Saxena (DOB 15/01/1974) (R.No.22007774) had been nominated by DSSSB for the post of PGT (Hindi) against post code 137/12 vide letter No. F.1(158)/DSSSB/P&P/2012/46-48 dated 23/01/2018 and result notice No. 585 dated 22/12/2017. Accordingly an offer of appointment was issued vide this office Memorandum of even No.383 dated 17/05/2018 for initial verification of documents on 04/06/2018.

2. Anupma Saxena (DOB 15/01/1974) (R.No.22007774) had been appointed vide order of even No. dated 10/08/2018 and been given Emp. I.D. 20182173 and posted in Tukmirpur, No.2 GGSSS-1104419 with direction to join latest by 07/09/2018. The candidate as per representation having Dy. No. 5910/E-II dated 07/09/2018 had sought extension and the same had been extension granted till 29/09/2018. Further the candidate has as per her representations dated having Dy. No. 6386/E-II dated 15/10/2018 replied denying acceptance of PGT(Hindi) with remark "I want to surrender the post as I am already PGT (Hindi) (by promotion). New posting venue is too far. Due to my health issues I don't want to join it."

Therefore, it can be see that, Anupma Saxena (DOB 15/01/1974) (R.No.22007774) is not interested in joining against the post of PGT (Hindi) and hence, the Directorate of Education has come to the conclusion that the candidate i.e. Anupma Saxena is no more interested to join against the post of PGT (Hindi).

Whereas, Parwati Baranwal (DoB 01/04/1986) (R.No.22001438) had been nominated by DSSSB for the post of PGT (Hindi) against post code 137/12 vide letter No. F.1(158)/DSSSB/P&P/2012/46-48 dated 23/01/2018 and result notice No. 585 dated 22/12/2017. Accordingly an offer of appointment was issued vide this office Memorandum of even No.365 dated 17/05/2018 for initial verification of documents on 30/05/2018.

Whereas, Naresh Kumar (DOB 10/07/1981) (R.No.22000605) had been nominated by DSSSB for the post of PGT (Hindi) against post code 136/12 vide letter No. F.1(158)/DSSSB/P&P/2012/46-48 dated 23/01/2018 and result notice No. 585 dated 22/12/2017. Accordingly an offer of appointment was issued vide this office Memorandum of even No.485 dated 18/05/2018 for initial verification of documents on 04/06/2018.

2. Naresh Kumar (DOB 10/07/1981) (R.No.22000605) had been appointed/posting vide order of even No. dated 10/08/2018 and been given Emp. I.D. 20182299 and posted in Janak Puri, Block-D, SBV-1720027 with direction to join latest by 21/08/2018. The candidate as per representation having Dy. No. 5772/E-II dated 28/08/2018 had sought extension and the same had been extension granted till 29/09/2018. Further the candidate had as per his representation dated having Dy.
