

Accordingly SDM (Patel Nagar) was requested to verify the OBC certificate issued to Sh. Vinod Kumar vide this office letters dated 04.12.2015, 07.01.2016, 13.07.2016, 30.08.2016 and 03.11.2016. But the same has not been verified by the certificate issuing authority till date. Therefore, the candidature of Sh. Vinod Kumar (Roll No.05112159) for the post of TGT(English) under post code 51/10 is hereby cancelled .

Ms. Sanuber Jilani was nominated by DSSSB vide letter No F.1(170)/DSSSB/P&P/ 2009/Vol.II/114-16 dated 23.03.2018 for the post of TGT(Urdu) post code 16/10 under UR Category bearing Roll No.01610016. Accordingly, an offer of appointment was issued to her vide this office memo No DE.3(14)/DR/E-III/2014/3510 dated 18.04.2018 with the direction to appear in person on 08.05.2018 in this office for verification of her educational qualification certificates and other documents.

Whereas, The candidate appeared for verification of documents on 08/05/2018. During verification of documents, the candidate submitted only one marksheet of Adeeb-E-Kamil issued from Jamia Urdu, Aligarh stating year 1998. From the marksheet it was not clear that which part/year it relates to. Therefore, a deficiency memo dated 08/05/2018 was issued to her with the direction to submit the marksheet of Part-I & II of her graduation.

Whereas, in response to this office deficiency memo dated 08/05/2018, Ms Sanuber Jilani replied vide her application dated 22/05/2018 stating therein that " Oriented degree course of Adeeb-e-Kamil offered by Jamia Urdu, Aligarh is equivalent to Graduation as per Govt. of India Order No.14021/2/78-Estt(D) Govt. of India, Ministry of Home Affairs, Department of Personnel and Administrative Reforms dated 28.06.1978. Your result Notice No. 606 dated 07.03.2018 also admit that Adeeb-e-Kamil from Jamia Urdu Aligarh may be considered for the post of TGT (Urdu) in Directorate of Education GNCT Delhi. This is to submit that in the year 1998, the course of Adeeb-e-Kamil offered by Jamia Urdu, Aligarh consist of 6 papers of Urdu language and literature and 2 papers of elective language. The copy of syllabus is attached herewith. **The duration of course was one year only in the year 1998.** " Hence as per the reply of Ms. Sanuber Jilani dated 22/05/2018 it is clear that she has done one year course of Adeeb-e-Kamil from Jamia Urdu Aligarh.

Whereas, the requisite educational qualification for the post of TGT(Urdu) as per existing Recruitment Rules for the post of TGT(MIL) are as under

(i) B.A(Hons) in one of the Modern Indian Languages(MIL) concerned OR B.A. with MIL concerned as one of the elective subjects from a recognized University having 45 percent marks in aggregate with one additional language or one school subject at degree level.

OR

Equivalent Oriental Degree in MIL concerned from a recognized University having 45 percent marks in aggregate.

(ii) Degree/Diploma in teaching OR Senior Anglo Vernacular Certificate.

(iii) Knowledge of Hindi is essential.

Whereas, after receipt of the reply of deficiency memo submitted by Ms Sanuber Jilani vide application dated 22/05/2018, it has been established that Ms. Sanuber Jilani has done one year course of Adeeb-E-Kamil from Jamia Urdu, Aligarh instead of three years degree course. Therefore, she does not fulfil the requisite educational qualification as per existing Recruitment Rules for the post of TGT(MIL). Hence, the candidature of Ms. Sanuber Jilani(Roll No.01610016) for the post of TGT(Urdu) under post code 16/10 is hereby cancelled and offer of appointment dated 18/04/2018 is withdrawn.
