**ORDER**

**Cancellation of appointment/posting order to the post of PGT  
(English) Post code (132/12)**

Whereas, Brijesh Kumar (DoB 16/12/1988) (R.No.33000321) had been nominated by DSSSB for the post of PGT (English) against post code 132/12 vide letter No. F.1(158)/DSSSB/P&P/2012/844-846 dated 09/08/2017 and result notice No. 524 dated 27/06/2017. Accordingly an offer of appointment was issued vide this office Memorandum of even No.2124 dated 01/09/2017 for initial verification of documents on 18/09/2017.

2. Brijesh Kumar (DoB 16/12/1988) (R.No.33000321) had been appointed/posting vide order of even No. dated 04/05/2018 and been given Emp. I.D. 20181222 and posted in Tukmirpur, No.2 GBSSS-1104420 with direction to join latest by 05/06/2018. It appears that the candidate is not interested to join against the post of PGT (English).

3. Further, DoPT Office Memorandum No. 35016/2/93-Estt.(D) dated 09/08/95 wherein para 2, the following has been mentioned "An offer of appointment should be clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period and **would lapse automatically after the expiry of six months from the date of issue of the original offer of appointment.**"

4. Therefore, in view of para.2-3 and OM referred to in para.4 above and with the prior approval of the Director, DoE, the appointment/posting order dated 04/05/2018 interalia candidature in respect of Brijesh Kumar (DoB 16/12/1988) (R.No.33000321) is hereby cancelled and the dossier is returned to DSSSB.
