ORDER

Sub: Proposal for setting up of Rogi Kalyan Samitis in each Assembly Constituency to facilitate and support the Delhi Health Institutions and Jan Swasthaya Samitis in Dispensaries / Polyclinics / Aam Aadmi Mohalla Clinics and Seed Primary Urban Health Centres (PUHCs).

The Council of Ministers vide Cabinet decision no. 2538 dated 29-12-2017, approved the following Proposals:

- A. Setting up of Rogi Kalyan Samitis in each Assembly Constituency to facilitate and support the Delhi Health Institutions in Assembly.
- B. Jan Swasthya Samitis under the Assembly Rogi Kalyan Samiti which shall function as its second tier peripheral executive subcommittees at the Health Facility Level with delegated executive powers will be created in each Aam Aadmi Mohalla Clinic, Dispensary / Polyclinic, & Seed Primary Urban Health Center.

Assembly RKS shall be registered under the Societies Registration Act 1860 with two tier Executive Sub-Committees. The Jan Swasthaya committee at Dispensaries/ Polyclinics / Aam Aadmi Mohalla Clinics and Seed Primary Urban Health Centres (PUHCs) shall be the second tier Executive Sub-committee of the Assembly RKS.

The above proposal has also been concurred by Hon'ble Lieutenant Governor vide his minutes dated 28-03-2017. The above order is issued subject to following conditions:

- 1. The Assembly Rogi Kalyan Samitis will be advisory in nature for assisting health facilities, developing & customizing strategies, rationalise & prioritise the health facility resources as per the memoranda of Association
- Jan Swasthaya Samitis will also be advisory in nature. The Medical officer In-charge of Health Facility will be directly responsible for running and administration of Health Facility as per financial power delegated to him even for expenditure provided under Assembly Rogi Kalyan Samitis.
- 3. The Jan Swasthaya Samitis will be constituted in Delhi Govt. Dispensaries /Polyclinics, Aam Aadmi Mohalla Clinics, and Seed Primary Urban Health Centres,. The Jan Swasthaya Samitis will be constituted as a sub-committee of Assembly Rogi Kalyan Samitis.
- 4. The Chief District Medical Officer/ Additional Chief District Medical Officer will have to ensure proper formulation and registration of the Assembly Rogi Kalyan Samitis/ Jan Swasthaya Samitis with Registrar Cooperative Society under Society Act
- 5. Each Assembly Rogi Kalyan Samiti and Jan Sawasthya Samiti will be provided Rs. 3 lakh per annum as Grant-in-Aid.

- 6. Each of the Assembly Rogi Kalyan Samitis will be registered under Societies Registration Act 1860 at Assembly Constituency level. They shall adopt by laws already approved for Rogi Kalyan Samiti (District) vide Cabinet decision dated 05/10/2009 with necessary changes in tune with the objective of these Societies as specified in the Cabinet Note.
- 7. The copy of Registration of Society will be immediately communicated to Directorate of Health Services.
- 8. DSHM will make all efforts to open a new budgetary sub-head in name of "Grant in Aid to Assembly Rogi Kalyan Samiti and Jan Swasthaya Samiti" for above purpose and sufficient Budgetary provision will be made. The fund allocated will be inclusive of funds approved under the Centrally sponsored scheme of National Health Mission and shall be as per existing provision.
- The Quarterly financial progress report of Assembly Rogi Kalyan Samitis/ Jan Swasthaya Samitis will be submitted regularly to Finance Department and Health & Family Welfare Department.
- 10. The approval of Govt. of India will also be sought on any amendment in the scheme, if Department deviates from the guidelines approved by Govt. of India.
- 11. The utilisation of fund of Assembly Rogi Kalyan Samitis/ Jan Swasthaya Samitis will be audited on annual basis and Audit report will be submitted regularly along with request for release of fund.
