3	201 to 500 Beds	Rs. 50 lakhs per annum
4	501 & Above	Rs. 75 lakhs per annum

The above proposal has also been concurred by Hon'ble Lieutenant Governor, vide his minutes dated 28-03-2017. The above order is issued subject to following conditions:

- Delhi State Health Mission will make all efforts to open a new budgetary sub-head in name of "Grant-in-Aid to RKS" and sufficient Budgetary provision will be made for the proposal. The fund allocated will be inclusive of funds approved under the Centrally sponsored scheme of National Health Mission.
- 2. The Quarterly financial progress report of RKS will be submitted regularly to the Finance Department as well as Health & Family Welfare Department.
- 3. The approval of Govt. of India will also be sought on any amendment in the Scheme, if Department deviates from the guidelines of the Govt. of India.
- 4. The utilisation of funds of RKS will be audited on an annual basis and the Audit report will be submitted along with request for release of fund.
