

ORDER

In compliance of Disciplinary Authority/Pr. Secy.-cum-Commissioner, F&S Department order No. F.12(221)/F&S/Vig./PF/15/304-309 dated 27.03.2018 wherein a penalty of reduction to a lower post in the time scale of pay of Gr.-III(DASS)/SA has been imposed upon Sh.
