No. 134/DS-II dated 16-11-2018 for enhancement of Dearness Allowance of Home Guard Volunteers from 7% to 9% performing their call out duty and GNCT of Delhi. The Directorate General Home Guards, Delhi is pleased to revise the Dearness Allowance of Home Guard Volunteer from 7% to 9% vide No.F.1/21/2015/HG/7230 dated 28.11.2018.

I am directed to convey the approval of Director General Home Guards for revision of Dearness Allowance from 7% to 9% w.e.f. 01-07-2018 as per vide OM No.1/2/2018-E-II(B), dated 07.09.2018 of Govt. of India, Ministry of Finance. The calculation of Daily Duty Allowance is as under:-

Basic Pay	Rs. 18,000/-
Dearness Allowance @ 9%	Rs. 1,620/-
Conveyance Allowance (Rs.40/- per day)	Rs. 1,200/-
Total	Rs.20,820/-

Daily Duty Allowance Rs. 20,820/- (30 Days month) = Rs. 694/- per day.
