In the last weekly review meeting held in the office of Hon'ble Minister (I&FC) on 17.02.2017, a copy of minutes thereof has already been made available in the office of SE (FC-II & III), it was desired by the Hon'ble Minister (I&FC) that an advertisement design may be prepared highlighting the various initiatives including number of new proposals under consideration with the department and the concept of the development of new Chhath Pooja Ghats in an eco and environmental friendly manner. An action taken/ progress report on this issue is still awaited from Shri O.P. Srivastava, SE (FC-II & III).
