ORDER

In supersession of all the previous orders and to streamline the process of allocation and re-appropriation of budget of the department under all major heads it is hereby ordered as under:-

ALLOCATION / RE-APPROPRIATION OF BUDGET OF THE DEPARTMENT UNDER DIFFERENT MAJOR HEADS

- 1 The budget allocation and re-appropriation of the entire department shall be approved at the level of Special Secretary / Additional Secretary / Joint Secretary (I&FC), as the case may be in the beginning of the year and at any such time when the need of re-distribution / re-appropriation of the budget between the two zones of the department is felt necessary during the financial year
- 2 Once the entire budget is divided / distributed / allocated in the proportion of the budget requisitioned by the concerned Chief Engineer (Zone-I & II), further allocation among the Circles and Division offices shall be done by the concerned Chief Engineer of the Zone
- 3 Further all files relating to distribution / re-appropriation of the budget of all the major heads of the department shall be routed through the Accounts functionary of the department within the parameters of existing procedure and rules and regulations

- 4 The proportion of budget to meet the financial requirement of headquarter shall be allocated to Chief Engineer (Zone-I)
