- 1. The Promotion on ad-hoc basis is effective from the date of assumption of charge of the post of Ahlmad by the official.
- 2. The Ad-hoc promotion to the post of Ahlmad shall not bestow on the incumbents any claim for regular promotion to the post.
- 3. The Promotion is being made—purely on ad-hoc basis and the ad-hoc promotion will not confer any right for regular promotion.
- 4. The Service rendered on ad-hoc basis in the post of Ahlmad would not count for the purpose of seniority in the post of Ahlmad or for promotion to the next higher post.
- 5. The Ad-hoc promotion shall not confer any right on the incumbents to continue in the post of Ahlmad indefinitely and may be terminated at any point of time without giving any reasons thereof.
- 6. The Promotion shall be initially for six months or "until further order", whichever is earlier. The Government reserve the right to cancel at any time the ad-hoc promotion and revert the government servant to the post from which he/she was promoted.
- 7. The ad-hoc promotion will remain subject to outcome of Hon'ble Superme Court of India and Hon'ble Delhi High Court orders and decision of Govt. of India in this regard.

The benefit of promotion will be admissible to the above mentioned officials only with effect from the actual date of their joining the post of Ahlmad.
