The applicant sought the information under RTI Act, 2005 vide ID No.14159/18. PIO (LA) did not furnish the reply of the said RTI.

The applicant filed an appeal on 05.09.18 under section 19 of the RTI Act, 2005 before the undersigned with request that direct the PIO to immediately release the information sought RTI,, ID No. 14159.

In response to the appeal filed by the applicant dated 05.09.18, hearing notices were served to all the parties with request to appear before the First Appellant Authority on 18.09.18 with relevant documents. However, hearing could not take place due urgent meeting. Accordingly next date of hearing was fixed on 25.09.18.


On 25.09.18, Shri D.K. Srivastav, S.O. on behalf of the PIO appeared and submitted that the information pertains to LAC (South) and his appeal forwarded to LAC (South) vide letter dated 11.09.18. A copy of the letter also forwarded to the appellant.

On the other hand, present Shri Surender Singh, appellant submitted that the reply RTI, ID No.14159 is not received till date.

I have gone through the submission of both the parties and available records submitted by the appellant, PIO (E.P. Cell) is directed to furnish information as available on record under section 4 and 6 of Land Acquisition Act, 1894 which is available with the department to the appellant within 15 days of receipt of this order as per provisions under the RTI Act, 2005. Further details of the RTI ID No. 14159 are forwarded to concern LAC.

Appeal is disposed of accordingly.

In case of appellant is not satisfied with the information provided above he can file 2nd appeal before the Second Appellant Authority i.e. Central Information Commission, Baba Gang Nath Marg, 3rd Floor, Munirka, New Delhi – 67.
