The applicant sought the information under RTI Act, 2005 vide ID No.14184/18.

The applicant filed an appeal on 19.09.18 under section 19 of the RTI Act, 2005 before the undersigned and submitted that the sought information be provided immediately of RTI ID No. 14184/18.

In response to the appeal filed by the applicant dated 19.09.18, hearing notices were served to all the parties with request to appear before the First Appellant Authority on 11.10.18 with relevant documents. However, hearing could not take place due urgent meeting. Accordingly next date of hearing was fixed.


On 31.10.18, present Shri Umesh Singh Nimesh, appellant who requested that copies of all the pages of noting side, correspondence side, entire set of documents supplied by the CBI and details of officers i.e. name and designation be provided to him.

On the other hand, Ms. Renu Tiku Bag S.O. on behalf of the PIO, submitted that information could not supply due to fact that it may impede the process of investigation or apprehension or prosecution of offenders and concern file is not available with the department.

I have gone through the submission of both the parties, the information furnished by the PIO is vague is nature. PIO (Vig.) is directed to provide the copies of relevant information with 15 days of receipt of this order as per provisions under the RTI Act. In case it is not available it may be forwarded to concerned PIO. Further, in case PIO think that it may hampered the process of investigation, a detail reasoned order be passed. If, need be the verified of CBI be also taken.

Appeal is disposed of accordingly.

In case the appellant is not satisfied with the information provided above he can file 2nd appeal before the Second Appellant Authority i.e. Central Information Commission, Baba Gang Nath Marg, 3rd Floor, Munirka, New Delhi – 67.
