The applicant sought the information under RTI Act, 2005 vide IDs No. 14384.

The appellant filed an appeal on 22.11.18 under section 19 of the RTI Act, 2005 before the undersigned and stated that he is not satisfied with the information provided by the PIO.

In response to the appeal filed by the appellant dated 22.11.18, hearing notices were served to all the parties with request to appear before the First Appellant Authority on 06.12.18 with relevant documents.

On 06.12.18, Shri S.K. Malhotra appellant appeared before the undersigned. Shri Rakesh Kumar, AAO appeared for the PIO.


A copy of the letter dated 04.10.1982 was shown by the appellant which was issued from Land and Building Department and given to Shri Rakesh Kumar, AAO. The appellant sought the original file from which this letter was issued.

I have gone through the submissions of both the parties. PIO (LM) and PIO (Housing Loan) are directed to allow the inspection of the concern file/record, if available with the department, to the appellant on mutually convenient date and provide the complete information as available on record, on the basis of inspection done by the appellant within 15 days of the receipt of this order as per provisions under the RTI Act, 2005. Further, one shadow file

namely, The Delhi School Teachers Cooperative House Building Society may be shown to the appellant in which the detail of sending of file to DDA is available and copy be provided, if required by the appellant.

Appeal is disposed of accordingly.

In case the appellant is not satisfied with the information provided above he can file 2nd appeal before the Second Appellant Authority i.e. Central Information Commission, Baba Gang Nath Marg, 3rd Floor, Munirka, New Delhi - 67.
