The applicant sought the information under RTI Act, 2005 vide IDs No. 14369, 14368, 14367. On the request of the applicant all the three RTI's are clubbed together as issue is same in these RTI's.

The appellant filed an appeal against the RTI's ID No. 14369, 14368, 14367 on 22.11.18 under section 19 of the RTI Act, 2005 before the undersigned and stated that he is not satisfied with the information provided by the PIO.

In response to the appeal filed by the applicant dated 22.11.18, hearing notices were served to all the parties with request to appear before the First Appellant Authority on 06.12.18 with relevant documents.

On 06.12.18, Shri Mukhtyar Singh appellant appeared before the undersigned. Shri R.K. Mudgil, Sr. Assistant appeared for the PIO.

Appellant has filed above mentioned three RTIs applications in which various information was sought regarding the acquisition of land in various villages i.e. Shadipura and Khampur Raya.

I have gone through the submissions of both the parties, PIO (LA) is directed to allow the inspection of the concern file/record pertaining to acquisition of these village which include LR register to the appellant on mutually convenient date and provide the complete information as available on


record, on the basis of inspection done by the applicant within 15 days of the receipt of this order as per provisions under the RTI Act, 2005.

The applicant also informed that in the RTI reply, the name and address of First Appellant Authority was not mentioned which is mandatory as per provisions of the RTI Act.

PIO is directed to ensure that information regarding the First Appellant Authority is provided in all the information/reply.

Appeal is disposed of accordingly.

In case the appellant is not satisfied with the information provided above he can file 2nd appeal before the Second Appellant Authority i.e. Central Information Commission, Baba Gang Nath Marg, 3rd Floor, Munirka, New Delhi - 67.
