The applicant sought the information under RTI Act, 2005 vide ID No. 14233.

The appellant filed an appeal on 18.10.18 under section 19 of the RTI Act, 2005 before the undersigned and submitted that he has not received reply from the PIO.

In response to the appeal filed by the appellant dated 18.10.18, hearing notices were served to all the parties with request to appear before the First Appellant Authority on 14.11.18 with relevant documents. However, hearing could not take place due urgent meeting. Accordingly, hearing was done on 22.11.18.

On 14.11.18 Shri Rahul Bhandari authorized representative submitted his statement that the matter may be decided on merit and information be provided. None from the PIO.


I have gone through the submission of the RTI appeal dated 18.10.18 alongwith with available documents and reply by the Nodal Officer (RTI) dated 21.08.18.

The sought information by the RTI ID No. 14233 dated 06.08.18 was perused and it transpired that apparently it pertains to PIO/Dy. Director (NL-I), DDA, Land Management, (NL-I), A-Block, 3rd Floor, Vikas Sadan,

New Delhi – 23 and The PIO, Land and Development Office, A-Wing, 6th floor, Moulana Azad Road, Nirman Bhawan, Delhi – 110001 and the same was duly forwarded to them by the Nodal Officer (RTI) as this matter is more closely related with these departments.

Appeal is disposed of accordingly.

In case the appellant is not satisfied with the information provided above he can file 2nd appeal before the Second Appellant Authority i.e. Central Information Commission, Baba Gang Nath Marg, 3rd Floor, Munirka, New Delhi – 67.
