### Brief facts of the complaint

The complainant has filed a complaint of inaction against PS Jyoti Nagar. She has stated that she made a complaint against her daughter in law of abusing and assaulting her in Police Station Jyoti Nagar. But the police has not taken any action on her complaints. She has further stated that she was an old lady of 65 years of age and was unable to resist further atrocities of her daughter in law and was left with no other option but to commit suicide. The police personnel instead of providing her some security, threatened her that her daughter in law may lodge some serious complaints against them and for which they may be imprisoned. She has requested for necessary action in the matter.
