1. Brief facts of the complaint

The complainant has filed a complaint stating that she had lodged a complaint on 25/10/2017 in Mehrauli Police Station as her husband was missing since 24th October, 2017. She has alleged that police department did not take any action on her complaint. The complainant has requested for necessary action in the matter.

The PGC convened its first hearing in the complaint on 13th February, 2018, when the following were present:-

3 Relevant facts emerging during the hearing

An ATR has been filed by HC Rajeev Kumar, PS Mehrauli stating that " the complainant has lodged missing report of her husband, namely, Mukesh Bisht s/o Shri Kanwar Singh, age 35 years vide DD NO. 33-A dated 25.10.2017 at PS Mehrauli, New Delhi. The call details of the mobile phone for IMEI search of missing person was sent but location of the same could not be established so far and mobile phone is still switched off. All the formalities have been made to trace out the missing person but despite of best efforts missing Mukesh Bisht could not be traced so far. As regards allegations against the Ravi Rai, the husband of Sanjana Rai, it is submitted that enquiry has been conducted from the Ravi Rai in detail. The statements of Ravi Rai has also been recorded in which he has stated that he alongwith his wife Mrs. Sanjana Rai, age about 35


years , son Abhishek , age 14 years and mother-in-law Smt. Urmila residing at Masoodpur, Vasant Kunj, New Delhi on rented accommodation. He is shopkeeper and his wife also running a shop of readymade garment near his house. On 23.10.2017 he doubt on the activities of his wife and he found that his wife was chatting with unknown person. His wife suddenly missing from his house on 24.10.2017 and thus he has lodged missing report of his wife Smt. Sanjana Rai at PS Vasant Kunj vide Dd NO. 25-A, dated 25.10.2017. He further stated that his wife also took cash of Rs. 2 lakhs from his shop and house and till date whereabouts of his wife is also not known. He further stated that his role is not in missing of his wife and Mukesh Bisht. Since, both the missing persons are major and as per enquiry conducted so far, both the missing persons gone on the same day and till date both are untraced. Efforts are being made to trace out the missing person."

4. Directions of PGC

EO is advised to make his sincere efforts to trace out the missing person.

With this advice, the Commission has decided to close the case in PGC.
