1. Brief facts of the complaint

The complainant has filed a complaint of inaction against ACP/Safdarjung Division and DCP/South. She has alleged that her daughter Priyanka , aged 19 years was missing /left home without informing anybody in the family since 3.45 p.m. , dated 7.8.2017. The following day relatives were enquired whether she was with them but she did not visit any relative. On further enquiry, it was known that she was with a boy named Anil of the same locality. The police did not register the complaint inspite of giving full particulars of the alleged person. She filed complaints in this regard with the ACP and the concered DCP but no action has been t aken by the police yet. She has requested for necessary action in the matter.

The PGC convened its first hearing in the complaint on 10th October, 2017 and the second hearing held on 13th February, 2018, when the following were present:-
