**1. Brief facts of the complaint**

Shri Sunil Kumar filed a grievance in PGC on 28.11.2017 regarding removal of illegal unauthorized construction in between the road.

3.1 A reply was submitted by E.E. [M.Shah.(N)]-I stating that Jagat Puri Ext. is an unauthorised colony not with EDMC. As per office order of Govt. of NCT of Delhi vide No. F.1-33/UC/UD/Policy/07/Partfile/CD-021297485/350-361 dt. 10.03.2016 all unauthorized colonies will be maintained and developed by DSIIDC.

3.2 *The complainant was not present during the hearing..*

4. **Directions of the PGC**

The matter does not relate to EDMC as the colony is unauthorized. Complainant is not present during the hearing. Under the circumstances there is no option left but to close the case at the level of this Commission.
