#### 1. Brief facts of the complaint

The complainant has filed a complaint of cheating by one Anand Arora through his company ABTOZ Trading Pvt. Ltd. He has stated that the same person had cheated many people in 2009 through his NGO Anand Jan Sewa and for that he remained in jail till 2016. But after his release on bail he has started his company and is doing the same kind of activities i.e. promising the clients two items @ only one and further he is compalling them to add on two members. He has stated that PS Ambedkar Nagar is already aware about his activities. He has requested for legal action in the matter.

### 4. Directions of PGC

The matter relates to cheating by way of multi-level marketing under the bearer of NGO Anand Jan Sewa to help weaker sections. The complainant reported that the founder Anand Arora had earlier been arrested in a similar case of fraud and cheating and has now started similar activities again post his release.

SHO (PS Ambedkar Nagar) is advised to personally verify the allegations and find out whether founder Anand Arora has any criminal record. In case the illegal activities are being run, as alleged by the complainant, the police may initiate legal action thereof or concerned specialized agency of police be informed for further action. The local residents should be educated/made aware not to induldge in multi-level marking and similar other activities.

With the above advice, the Commission has decided to close the case in PGC.  $\emptyset$
