**1. Brief facts of the complaint**

The complainant has filed a complaint of misbehaviour and not registering her FIR on her complaint of beating by her husband's brother, against SI Uday Singh of PS Bawana. She has alleged that the said SI was taking the plea that the MLC report was not received whereas the hospital authorities told that they had already sent the MLC. She has requested for legal action in the matter.

**2. Proceedings in the Public Grievances Commission**

The PGC convened its first hearing in the complaint on 8.2.2018, when the following were present:-

**3 Relevant facts emerging during the hearing**

An ATR has been filed by SI Uday Singh, PS Bawana, stating the following :-

- i. It is submitted that the PCR call vide DD NO. 82B dated 17.8.2017 PS Bawana was entrusted to the undersigned. The house of the complainant was visited immediately but nobody was found there and the complainant had already been moved to the hospital by the PCR. After her treatment, the statement of the complainant was obtained in which she stated that she has been beaten by

Ashok with kicks, slaps and punches. The MLC was received in which two injuries were mentined, one swelling on perital area and bruise on arm, the nature of injury was reserved by the doctor. The MLC has been deposited for result on nature of injury and on 4.10.2017, the result was prepared by t he doctor as "Simple".

- ii. Thereafter, a report u/s 323 IPC was lodged in the daily diary vide DD No. 20A dated 14.10.2017 as only the offence u/s 323 IPC was made out from the statement and MLC of the complainant which is non cognizable. The complainant was duly informed regarding the action taken and copy of MLC, statement and theDD entry was handed over to her.
- iii. It is further submitted that the due legal action has already been taken on this complaint as no cognizable offence has been made out. The complainant was duly informed regarding the action taken and copy of MLC, statement and the DD entry was handed over to her. The complainant and her family members have met with the undersigned many times and they were attended in very professional manner and were informed about all the facts related to this complaint."

#### 4. Directions of PGC

In view of the above, the Commission has decided to close the case in PGC.
