1. Brief facts of the complaint

The complainant has filed a complaint alleging unnecessary delay in registration of accident case by IO/ASI Rajender Kumar. He also alleged that his injured father was made to sit in PS for more than three hours. The complainant has requested for necessary action in the matter.

An ATR has been filed by Inspector Akshay Kumar, SHO/PS Badli, stating the following :-

i. An enquiry was got conducted into the allegations of the complainant and on enquiry, it was revealed that on 4.10.2017, a PCR call vide DD NO. 3A was marked to ASI Rajender Kumar regarding accident near Samaypur Badli, Station and for the compliance of the same he reached at spot and found one

accidental bike bearing NO. DL-11-SE-7101. He brought the same to PS and thereafter collected the MLC bearing NO. 13976/17 of injured namely Keshav from BSA, Hospital, Delhi. He recorded the statement of the injured and got registered an accidental case vide FIR No. 861/17, u/s 279/337 IPC, at PS S.P. Badli, Delhi. The investigation of the same was marked to him and during course of investigation he arrested the accused and filed chargesheet before the Hon'ble Court . On 18.12.2017, he filed DAR before the Hon'ble Court of Shri Vidya Parkash, MACT Judge, and Rohini Court, Delhi, where complainant got compromised with accused and Rs. 12,000/- compensation was also sanctioned to him from the

Perusal of the ATR reveals that the police has taken the case to a logical conclusion and the complainant has compromised the matter, therefore, the Commission has decided to close the case in PGC.
