1. Brief facts of the complaint

3. Relevant facts emerging during the hearing

An ATR has been filed on behalf of DCA, Education (HQ), North DMC, stating that *“the case has been examined personally and report submitted to Dy. Director of Education*

dd DDO(Edn.), HQ. In the report, it has been mentioned that Sh. Rohitashva Kumar, SI who retired on 31.7.2011 from Education (HQ) is entitled for MACP 3rd. As per Clarification OM No.35034/1/97-Estt.(D)(Vol.IV) dated 10.2.2000 and the department has been advised to take further necessary steps to constitute proper Screening Committee for this Category A officer to consider the case for 3rd MACP.

The complainant expressed his satisfaction on the action taken by the Department.

4. Directions of the PGC

In view of the ATR filed by the Department, the case is closed in PGC with the advice to Shri James Paul, AO (CED), North DMC to coordinate with the concerned branch for redressal of the grievances of the Complainant and file an ATR intimating the Commission that the grievance of the complainant has been fully redressed.
