## **1. Brief facts of the complaint**

The complainant has filed a complaint alleging that on 4.9.2017 in between 10.30 p.m. to 11.00 p.m. SI Ompal and staff of PS Model Town reached at his residence and entered into his house after breaking the door and searched the entire house and SI Ompal forcibly took Rs. 15,000/- kept below the cushion in his outer room. He has also alleged that SI Ompal and staff of PS Model Town slapped him and abused the whole family members including his mother, sister and wife. He has further alleged that earlier his brother Sunder Yadav @ Babu has got life threatening bullet injuries and a case vide FIR No. 61/2016 u/s 307 IPC & 25/54/59 Arms Act has been registered in this regard and noted criminal Mahindra Pahalwan @ Dharmendra Sisodia is behind this incident and he has been declared PO by the court and local police is protecting him instead of arresting him. He called at NO. 100 but no police action was taken. The complainant has requested for legal action in the matter.

The PGC convened its first hearing in the complaint on 7<sup>th</sup> December, 2017, the second hearing held on 8<sup>th</sup> February, 2018 and the third hearing held on 22<sup>nd</sup> February, 2018, when the following were present:-
