1. Brief facts of the complaint

Sh. V. K. God filed a complaint in PGC on 13.10.2017 stating about the encroachment on MCD Ramlila Park, Y-Block, Phase-II, Nangloi. The complainant has requested for necessary action in the matter.

Relevant facts emerging during the hearing

3.1 At the last hearing held on 26th Dec. 2017, the directions of PGC were as follows :

The Deputy Commissioner (Narela Zone), North DMC and the Deputy Commissioner (West Zone), Revenue Department are advised to look into the matter for t he absence of the



concerned officials and non filing of ATR. They are also advised to ensure the presence of the concerned officials along with ATRs on the next date of hearing.

3.2 During the hearing held on 27.02.2018 Sh. Kishori Lal Sr. Asstt., SDM, Punjabi Bagh attended the hearing and submitted a report stating that:

The Revenue field staff of Sub Division Punjabi Bagh was directed to visit site and submit the report urgently. The main issue raised by Sh. V.K.God complainant relates to illegal construction of shops by demolishing the boundary wall of public place. As per report dated 23.02.2018 the NDMC has given the land to Punjabi basti Market Welfare Association Nangloi Regd. On the orders / directions of Hon'ble High Court of Delhi. At present Board is still fixed on the site stating the aforesaid version. The photocopy of the sign board along with photocopies of the sites are also enclosed herewith for your kind perusal.

In view of the above, it is evident that the matter pertains to North Delhi Municipal Corporation and necessary direction may be issued to them for submitting the status report with regard to the authenticity of sign board affixed at the site.

3.3 Neither any officer attended the hearing from North DMC nor any status report has been filed.

4. Directions of the PGC

As the land has been given by North DMC to Punjabi Basti Market Welfare Association Nangloi Registered on the orders / directions of Hon'ble High Court of Delhi the matter stands closed at the level of PGC.
